Order

Sri Veeramusti Sathish, Jayashankar Bhupalpally District has filed 2nd appeal dated: 20-12-2023 which was received by this Commission on 05-01-2024 for not getting the information sought by him from the PIO / O/o the Station House Officer, Tekumatla Police Station, Jayashankar Bhupalapally District and 1st Appellate Authority / O/o the Superintendent of Police, Jayashankar Bhupalapally District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 05-08-2023 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) The daily progress made on my attached complaints dated 27/05/2023 and Oral complaint Case ID 20230003407199.
- 2) Reasons for delay in taking action on my complaints.
- 3) Names and designations of officials who have considered my complaints and the number of days it was lying with each official during this period.
- 4) Please provide copies of file noting indicating the consideration of my complaints from the date of receipt till date by the concerned officials. I would also like to inspect all documents relating to my case.
- 5) A copy of the rules/ regulations/ orders/ citizens charter which lay down the timeline for disposal of such complaints.
- 6) Names and designations of officials who are responsible for dereliction of duty for delaying my complaints in violation of relevant rules/ regulations/ orders.
- 7) Date by when action would be completed in my case?

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated 27-09-2023 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 28-08-2025 at 10.30 A.M.

The case is called on 28-08-2025. The appellant is absent. The PIO / Sri. D. Sudhakar, Sub-Inspector of Police, Tekumatla Police Station, Ramakistapur Village, Jayashankar Bhupalpally District is present and filed affidavit stating that the information was furnished to the appellant but failed to submit the copy of the same before the Commission.

The First Appellate Authority / Sri. Kiran Khare, Superintendent of Police, Jayashankar Bhupalpally District is present and filed his affidavit stating that vide letter no: 56/DCRB-JSB/2023 dated: 26-10-2023 the application was transferred u/s 6(3) of the RTI Act 2005 to the PIO / SDPO, Jayashankar Bhupalpally District with a direction to furnish the information to the appellant.

Heard the PIO and the first Appellate Authority and perused the material papers available on record. The Commission is not satisfied with the reply of the PIO and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of RTI Act 2005.

The Commission directs the PIO / O/o the SDPO, Jayashankar Bhupalpally District and the PIO / Sub-Inspector of Police, Tekumatla Police Station, ramakistapur Village, Jayashankar Bhupalpally District to furnish the complete information to the appellant within One (01) Week from the date of receipt of this order through Registered Post with Acknowledgement Due and submit compliance report to the commission.

With the above direction, the appeal is closed.
